## Electronic Delivery Consent or Opt-Out Form

The Rocky Ridge Properties Owners' Association periodically updates its records as to the respective addresses to use for purposes of delivering general association-related communication to the Association's members for Rocky Ridge POA and Board of Directors.

The Association **STRONGLY ENCOURAGES** members to authorize use of an email address for individual delivery of notices. When Members authorize the Association to use email for individual delivery of notices, *the Association achieves material cost savings and, further, may dedicate the work time of its employees more efficiently.* However, Civil Code section 4040(a)(2) provides that Association Members must consent in writing or by email to the receipt of notices by electronic delivery, and that consent may be revoked by written notice to the Association, or by email, at any time.
